## **Committee Reports**

#### Hunters Helping the Hungry:

Penny Hickman reported that there has not been much recent activity with the program. About 4800 pounds of meat has been distributed so far this year.

#### Jr. Hunter Pheasant Hunt:

Anthony Pittore stated that after review of last year's records, 18 kids are still eligible and will be sent applications for this year's hunt. Anthony will have applications available at the August meeting. This year's event is scheduled for September 24<sup>th</sup>.

## **Dutchess County Fair Exhibit:**

Ken Foster is working on getting the discounted tickets and passed around the sign-up sheet for volunteers. He has copies of the volunteer guidelines. Many time slots are filled, including some for which a club has signed up for the whole day. But there are still some slots to fill: Tuesday, Saturday, and especially Sunday.

### Outdoor Journal:

Bill Conner handed out an advertisement layout guide for the upcoming fair edition and discussed prices. He asked for help to ensure all outstanding ads are accounted for and to make sure they are included in the Fair edition. If you have facilitated any ads that did not make it into the Spring edition, please let Bill know. This is an area where we could really use some help – managing and coordinating ads.

### Conservation Education:

Scott Emslie reported that there have been no more kids that backed out of going to camp. He spoke with one kid that went to Pack Forest, who really enjoyed the camp. Pete Kraayenbrink, who volunteers at the Hunter Ed classes at Camp DeBruce, stated that there have been a lot of kids taking the classes.

### Fundraising:

Anthony Pittore is this year's chairman for the Club 36 raffle and has the tickets available.

#### Legislation:

Legislative Vice President Paul Annetts reported:

- The state legislative session ended with very little accomplished.
- Briefly reviewed several bills related to the definition of easy-opening knives, ATVs and snowmobiles, invasive Mute Swans, and increased gun purchase background checks.
- Pennsylvania has reported a very high incidence of mange in their bear population.
- NY is getting \$17.7 M in Pittman Robertson funds. These funds come from an excise tax on the sale of hunting and outdoor sports related supplies.

Bill Conners stated that there is a meeting in August and the Fall Convention in September.
