**Legislation Report** The Governor’s budget for 2017-2018 fiscal year is complete. Everything for hunters and the sporting community has been taken out. There’s fundamental questions that there will be any actions at all on the 480A that the Federation has been pushing on. The 12yr. old Universal Hunting Age is gone! Crossbow Legislation is gone! The Federation wanted work done to enhance the laddering investment plan for the trust account for the Lifetime Licenses wasn’t in there. It doesn’t mean that it won’t make it this year. It’s will take every Delegate making a phone call to their Assemblyman or State Senator to tell them what it is you’re looking for. You can go to the NYSCC website and look for bills that’s of interest to you and call your Legislator and voice your opinion.

National Wild Turkey Federation Regional Wildlife Biologist-Kaylee Resha sent Paul Annetts which is a member information on how some clubs may qualify for an NWTF biologist who may be able to provide guidance at no cost for landowners interested in creating and maintaining young forest or scrubland habitat on their land. The following New York State counties are targeted: Rensselaer, Columbia, Dutchess, Putman, and Westchester, however additional funding assistance may be available throughout New York State. Cost share funds may be available through Wildlife Management Institute's Four Year Regional Conservation Partnership Program award from the US Department of Agriculture National Resources Conservation Service to establish young forest habitat on private lands. The project is titled "The Young Forest Initiative for At-Risk Species". This means that the habitat work could be done at little or no cost to you with information regarding the program and possibly an in-person evaluation of your land.
