**Hunters Helping the Hungry:** 5100 Lbs. of game has been processed and distributed so far this year.

**Conservation Camps:** Nothing new to report

**Legislation:** Bill Conners reports that the outlook for success during the 2018 Legislative Session is no better than the last session. The Fish and Management Board and the Conservation Fund Advisory Board are going to go after three critical issues. This is an election year and it is not likely, very unlikely that the Governor will sign legislation that he deems controversial. Pushing any particular piece of gun legislation will likely amount to having no more than a distraction.

**Assembly Bill A00477 and Senate Bill S3156** We should all be focusing on the 12-year-Old Hunting Age bill. We need that for many reasons. If we do not start recruiting younger hunters, license sales will continue to fall and along with it, revenue. This will make it difficult to maintain the programs we have. If we can't increase revenues, we will need more support from the General Fund. That is a heavy bill.

**Empire Forrest for the Future:** The 480-A Program will not be expanded. Moving forward, the plan is to open up 480-B. New applications will not be accepted into 480-A. Hopefully, the Governors budget bill will take care of this. Stand by for more information in a week or two.

**Assembly Bill A5468 and Senate Bill S04575- Investment Plan for Lifetime Trust Account.** Just a couple of years ago the more than \$50 million in the Lifetime License Account was earning less than \$100,000 a year. It is now earning about \$800,000 and it should be earning much more. The Conservation Fund Advisory Board is working with the Comptrollers Office to get approval to expand the investment latitude. We could earn as much as \$2 million dollars a year. The interest earned on the account is used in the Habitat Conservation and Access Account. One program the account funds is the Young Forrest Initiative, a program that will create an early successional forest in Wildlife Management Areas across the state. The Division of Fish and Wildlife has hired eighteen foresters to manage the program. Matching funds from the Pittman- Robertson Fund have contributed to the program.

**Fish Stocking:** Stocking is planned for later this month. Stocking schedule will be printed later this month. Approx. 54000 fish will be distributed between all lakes and rivers.

**Conservation Camp** Nothing to report.

**Free Kids Fishing Day:** Free fishing day for kids on April 29, 2018 at Overlook Park. Free Hot Dogs and Soda will be served. Volunteers needed. Event starts at 9:00 am and ends at 1:00pm. No license required on this day and all rods and bait will be provided. It's a fun day for all.
