# February 9, 2023 Regular Delegates Meeting

Short Hills Restaurant, Washington Hollow, NY

The meeting was opened at 7:40 PM by President Anthony Pittore

The Pledge of Allegiance was led by Anthony Pittore.

A moment of silence was observed for armed services personnel, first responders, and past Federation members.

Roll Call: 25 people were in attendance, representing 16 clubs.

#### Guests

Deo Reed, DEC ECO, spoke on the following:

- Several people were bitten by a coyote in the Culinary Institute area of Hyde Park. The animal has not yet been located.
- ECO Davey of Columba County has retired.
- There has been some Striped Bass poaching in the Hudson River near Peekskill. The Stripers are already running up the river.

Anthony introduced a new delegate from East Hook Sportsmens Assn.: Frank Zaccaro.

Bill Conners introduced John Lobotsky from Rhinebeck, who is 97 years old, a longtime sportsman, a member of multiple Federation member clubs, and owner of Wonderland Nursery in Rhinebeck. Mr. Lobotsky spoke about the initiative to restore American Chestnut trees in Ulster and Dutchess County forests (and elsewhere), and his involvement with that initiative. A professor from Ithaca College, Alan Nichols, is a leader in this movement and has chestnuts available to those who wish to help. He can be reached at 607-263-5105. #### Minutes/Reports

The Treasurer's Report was accepted upon a motion by Ken Rose and a second by Skip North. All-in-favor (AIF).

### **Committee Reports**

### Hunters Helping the Hungry

Anthony Pittore reported that a deer cull is in progress in Westchester County and we have gotten some deer from it, with more expected to come. He thanked all who have been helping with the processing.

#### Fish

Anthony Pittore stated that the annual Family Fishing Day event is planned for Sunday April 23<sup>rd</sup> at Overlook Park in Lagrange. The event will be from 9:00 AM to 1:00 PM. The town is doing some tree and brush clearing from around the pond to make it more accessible for anglers.

Anthony also announced that we will be helping Trout Unlimited with a Veterans Fishing Day at the same location the day before on Saturday the  $22^{nd}$ . Same time 9:00 - 1:00. The pond will be stocked several days before the events.

## Jr. Hunter Pheasant Hunt

Anthony Pittore stated that the hunt is planned for September 23<sup>rd</sup>. He is working on obtaining the legal ability to buy and supply ammo for this event and for the Youth Trap League.

#### **Conservation Education**

Pete Kraayenbrink reported that we have sent the funds for the DEC camp sponsorships. Based on the latest information, we think we have applications for 12 kids. April 2<sup>nd</sup> is the opening date for registrations. Contact Scott at 914-475-1135 if you have more applications to submit or for more information.

### **Fundraising**

Ken Foster reported the official results of the annual 50/50 fundraiser. Receipts were \$6,520. The \$3,260 1<sup>st</sup> prize was won by Richard Brown (ticket 0041). The \$300 2<sup>nd</sup> prize went to Mike Humbert (0384), and 3<sup>rd</sup> prize of \$200 went to John Harkin (0046). Net income was \$2,760. Anthony Pittore thanked Ken for his efforts.

Tom Fiumarello stated that the Board of Directors approved moving forward with a Federation sponsored sporting clays shoot at Mid-Hudson Sporting Clays in New Paltz. Member clubs, private clubs, and first responders, will be invited to send teams to compete for "Best of the Hudson Valley" trophies. The shoot is intended to be primarily a great day of shooting and good food and comradery, and secondarily a fundraiser, which could potentially eliminate the need for an annual raffle. The shoot is planned for Saturday July 15<sup>th</sup>. He encouraged all clubs to send teams to make this event a great success. More information will be made available at the next regular meeting.

Tom also mentioned that he will again be organizing a sporting clays shoot for Canine Cancer Research this year. The Conservation Awareness Foundation (CAF) will be co-sponsoring the event. It will be held on June 17<sup>th</sup>. There will be a lot of prizes and raffles. Previous years' events have been very well received and have raised a lot of money for this cause.

#### Legislation (and other conservation news)

Bill Conners spoke on the following topics:

- The state CFAB board still does not have a representative from Region 3, even though candidates have been presented to state legislature to appoint. Bill asked for a motion to send a resolution to the NYS Assembly majority leader to fill the seat. Ken Rose made the motion with a 2<sup>nd</sup> by Skip North. AIF.
- Under the heading of incredulous bills introduced by apparently clueless legislators, a Wildlife Crossing Act is a bill in the state Senate. How to convince wildlife to cross at the designated places is still TDB. (Bill# S4198).

- NYS Senate bill# S1725 would add more protections for class C waters, like the small Fallkill Creek. It is saying there will be no fiscal implications, which is not possible.
- Bill provided copies of the 2023 Legislative Guide which lists all the legislative representatives relative to Dutchess County, at all levels and their contact information. He will email out a PDF version of the guide.
- The NY courts have bundled all of the lawsuits against the Concealed Carry Improvement Act (CCIA), so that all the arguments can be heard at the same time, which will be in March. It will likely go to the US Supreme Court.
- More states are enacting similar laws as the CCIA.
- NY is also placing much more stringent regulations on FFL gun dealers, making it very difficult for small dealers to stay in business, and therefore making it harder to buy guns and ammo. The state is basically suffocating gun ownership via multiple ways.
- Bill believes that the various groups behind the lawsuits are putting up a good fight, especially Gun Owners of America (GOA). But it is very costly. So gun owners and organizations will have to step up to financially support these groups.

Bill asked for a motion to ask the Board of Directors to consider a donation to GOA for an amount to be determined by the Board. Pete Kraayenbrink made the motion and a 2<sup>nd</sup> by Ken Foster.

A lot of discussion ensued about the role of the Federation to support the gun rights effort and how much. John O'Donnell, 110 Rod & Gun Club delegate, specifically asked what the Federation is doing for member clubs to support gun rights, so that he can report that back to 110. John was non-committal when asked what 110 is doing beyond his sharing of information on the laws and lawsuits amongst its members.

Bill Conners stated that he believes that shifting the Federation's lobbying efforts from fish and wildlife and conservation issues to gun rights issues, will only reduce our effectiveness with the conservation issues. There are many other groups better equipped to fight for gun rights. And that was the reason he asked for the motion to consider a donation; to stay within our mission but to give some support.

Bill encouraged clubs and their members to donate, as able, to the groups directly, but to let us know so that we can document the total that Dutchess County clubs have donated. (Ulster County has donated over \$30K so far.)

Anthony Pittore recited the Federation's Objective (aka mission statement) from the ByLaws. See attached.

The motion on the floor was finally voted on and carried.

Attachment - Bylaws excerpt:

# ARTICLE II OBJECTIVES

- Section 1 The objectives of the Federation shall be to unite the sportsmen's clubs of Dutchess County in the endeavor to create closer cooperation among themselves, with landowners, with the New York State Department of Environmental Conservation and with all others interested in conserving the wildlife and all other natural resources; to assist in the propagation and distribution of fish and game; to foster desirable conservation legislation; to improve game protection and reduce game law violations to the end that good fellowship between legislators, landowners, sportsmen's clubs and sportsmen generally, may be promoted. Organization promotes the economic value of hunting, fishing, trappings, and recreational shooting in New York State.
- **Section 2** The Federation shall be an annual member of the NYSCC Inc.
- **Section 3** The Federation at the discretion of the Board of Directors shall be an annual member of The NRA Inc.
