Roll Call: 23 people were in attendance, representing 17 clubs.

# <u>Guests</u>

Deo Reed, DEC ECO, spoke about the following:

- There will another ECO academy next year, separate from the Forest Ranger academy.
- The ECOs are being issued new firearms, 9mm to replace the current .40 caliber.
- They are also implementing a new radio system.
- There are still incidents of striped bass poaching in the lower Hudson River.
- They are seeing increased instances of coyotes with mange and rabies. Please be aware and careful when approaching, or being approached, by these animals.

### Legislation (and other conservation news)

Bill Conners reported that not much legislation is moving in Albany at the moment, due to ongoing budget negotiations.

One bill introduced was S03302, which would make it illegal to bring back and possess "Big 5" animals hunted in Africa.

The bundled CCIA lawsuits will soon be heard in the Federal Circuit Court. Gun Owners of America (GOA) is leading that effort.
